"We handle it the way we've always handled it. We work with local health officials; we reconcile any of the discrepancies. We've done that consistently since the beginning of this pandemic. We continue to work very collaboratively with local health officers in Orange County. And we look forward to making an announcement updating that monitoring list."

Orange County was put on the watchlist around the end of June. This marked the beginning of many local businesses being shut down by the state.

In Stanton, there were closures of all bars and indoor operations at restaurants, movie theaters, malls, hair salons and nail salons. However, later various businesses, like restaurants, have been able to operate outside.

With the county being off the watchlist, it is hopeful that more businesses could reopen in the future with fewer restrictions if it is safe. This decision will come from California State Health officials.

The Orange County School Board could begin reopening schools if the county stays off the watchlist for 14 days. This would be good news for both students and parents. Many are struggling to help teach their kids at home and provide day care.

Meanwhile, state guidelines that need to be met for Orange County to open continue to be slowed as even with the three-day lag a few

test result continue to be scrutinized for three-day delays in local test results.

The three-day lag has created an accounting problem in Orange County statistics compared to state data collected during the same

Here is an example of a three-day lag. Covid-19 numbers calculated on April 1st would correspond to cases occurring from March 25th – March 28th. These case rates are often calculated using the date they were reported to the health department this measure uses the episode date. Therefore, it could create some inaccuracies.

The ambiguity of the episode date is between the day the test result was discovered versus the date when the test specimen was collected. The Orange County Health Care Agency tallies the cases by when the specimens were collected. While the State uses a different date measurement

Some residents said the county Health Care Agency stopped using a three-day lag to calculate its cases per 100,000 residents, and instead switched to a two-day lag time. This has a potential to affect the data results

Here is an example of how you can get different results in data that is collected. If data totals showed 104.6 cases per 100,000 residents while using a three-day lag but by using a two-day lag, the case count was nearly 94.

There is a good chance that

tests results would not fall into the reporting period.

Some residents are concerned because it has taken in some cases over a week to get their Covid-19 test results.

Meanwhile local business owners in Stanton and the rest of Orange County toil to stay open and keep fighting having to close for good. Our town was able to help nearly 150 small businesses with CARES funding in the form of grants that do not have to be paid back, assisting many to remain open and continue their efforts to

State health officials are expected to announce updated statewide reopening guidelines. They also will be addressing the County of Orange Health Care Agency's metrics.

New county guidelines that affect Stanton and our neighboring cities are expected from Governor Newsom's office regarding reopening sectors of the county that could include shopping malls, gyms, and

All counties in California must be off the watchlist for 14 consecutive days before sectors can be considered for reopening by state Health Care Agency officials.
