Stanton offers COVID testing on Saturdays

Official urges residents to do their part to keep community safe

This week's article will hopefully provide everyone a better understanding of Governor Gavin Newsom's Stay at Home Order.

Our Southern California region dropped below the 15 percent Intensive Care Unit (ICU) capacity, thereby triggering the state of California's "Regional Stay-at-Home Order" as was announced on Dec. 3 by Governor Newsom.

As a result, Orange County residents will be required to stay at home as much as possible and not mix with other households to reduce exposure.

Due to our regional ICU capacity dropping below 15 percent, the state's regional Stay-in-Home Order closes the following sectors:

indoor and outdoor playgrounds, indoor recreational facilities, hair salons, barbershops, personal care services, museums, zoos, aquariums, movie theaters, wineries, bars, breweries, distilleries, family entertainment centers, card rooms, satellite wagering, limited services, live audience sports and amusement parks.

The following sectors in the Southern California region will have additional modifications in addition to 100 percent masking and physical distancing.

· Outdoor recreational facilities: Allow outdoor operation only without any food, drink, or alcohol sales. Additionally, overnight stays at campgrounds will not be permitted.

· Retail: Allow indoor operation at 20 percent capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or com-

promised immune systems. · Shopping centers: Allow indoor

operation at 20 percent capacity with entrance metering and no eating or drinking in the stores. Additionally, special hours should be instituted for seniors and others with chronic conditions or compromised immune systems.

· Hotels and lodging: Allow to open for critical infrastructure support only.

Restaurants: Allow only for take-out, pick-up or delivery.

 Offices: Allow remote only except for critical infrastructure sectors where remote working is not possible.

· Places of worship: Allow outdoor services only.

· Entertainment production including professional sports: Allow operation without live audiences. Additionally, testing protocol and 'bubbles" are highly encouraged.

The state Stay-at-Home Order does not modify existing Orange County or state guidance regarding K-12 schools.

The following sectors are allowed to remain open in Orange County when a remote option is not possible with appropriate infectious disease preventative measures including masking and physical distancing: critical infrastructure, non-urgent medical and dental care, childcare and pre-K.

Regionally the County of Orange will remain in the state Stayat-Home Order status for at least three weeks. Then, regionally, the County of Orange may come out of the Stay-at-Home Order after three weeks, if at that time, hospital ICU capacity projected four weeks out reaches at least 15 percent.

Then, regionally, Orange County will return to the Blueprint for by its case rate and test positivity. If the ICU capacity of Orange County is less than 15 percent after the three-week period, the ICU capacity will be assessed weekly to determine when the order can be lifted.

In addition, the state's Stay-at-Home-Order will place the following restrictions on Orange County on non-essential travel lodging.

Except as otherwise required by law, no hotel or lodging entity in California shall accept or honor out of state reservations for non-essential travel, unless the reservation is for at least the minimum time period required for quarantine and the persons identified in the reservation will quarantine in the hotel or lodging entity until after that time period has expired.

During this time, the state Stayat-Home-Order encourages members of the same household are to maintain physical and mental health by safely going to a park, hike, walk or bike ride when safe to do so and socially distanced.

Orange County residents are also encouraged to keep connected with loved ones virtually. For more information, visit the

state's COVID-19 website.

There are several steps Orange County residents can take.

First, get tested for COVID-19. OC Health Care Agency officials are urging residents, especially those with any symptoms, to get tested for the virus. COVID-19 testing is now widely available across the county for those who are symptomatic or asymptomatic, with or without insurance, at no cost. Testing takes only a few minutes and results generally come

a Safer Economy tier determined back within two to three days. If you test positive for COVID-19, stay home, and let close contacts know. A close contact is someone you were within 6 feet for at least 15 minutes within a 24-hour period during the infectious period.

> Second, stay home if you do not feel well. Consult with a health care provider. If you do not have a health care provider, please call the OC Health Care Agency's health referral line at 1-800-564-8448

> Third, stay home when possible. When you leave the house, avoid crowds, and stay 6 feet apart from people not in your household.

> Fourth, do not gather. Do not mix households at this time.

> Fifth, wear a face covering. Wear a face covering when you are around people not in your household, especially when indoors.

> Next, wash your hands often. Wash your hands often with soap and water for at least 20 seconds.

> Avoid touching your eyes, nose and mouth with unwashed hands. Clean and disinfect frequentlytouched surfaces.

> Understand and comply with the state's guidelines for your business and events. Orange County residents may search for a business or activity type by visiting https://covid19.ca.gov/ safer-economy/ and typing in "Orange" in the County field, entering the business or activity type, and clicking "GET LATEST STATUS.

The first FREE testing site in our town last Saturday was a great success with close to 700 tests given to those who scheduled appointments. We will continue testing every Saturday at the corner lot located at 11052 Beach Blvd. in Stanton from 9:30 a.m. to 4 p.m.

Covid-19 testing is open to all Stanton residents and our surrounding communities with or without symptoms of the virus. You can walk up or come by car.

Appointments are the only requirement so schedule your test at oc.fulgentgenetics.com or if you need help call 714-805-7838. Masks must be worn on site.

This week was highlighted by our own city staff helping me deliver 13 pallets or 10,000 pounds of food to seniors and families in our town. I was able to acquire the food with the help of Friends of Families Charity, Super King Markets, and OC Food Bank Community Action Partnership.

The drive-thru distribution included boxes of food with apples, onions, tomatoes, yogurt, chicken patties, milk and cheese. Plus, turkeys with stuffing, canned tuna, cliff junior bars for kids, and pork roasts.

I want to thank Mr. Allan Rigg and our city public works folks for their helping picking up and unloading the food. It was distributed by our Community Services Department members and organized by Zenia Bobadilla, the director.

The city will try to continue to distribute food to our seniors and those in need over and beyond the holidays.
