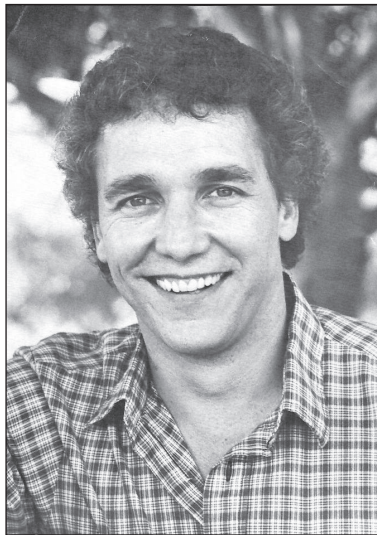


Memories of Buena Park from TV actor/educator Frank Pangborn

Readers might recognize his face, since Frank Pangborn, raised in Buena Park, has appeared in more than 50 TV episodes of such popular shows as Dallas, Murder She Wrote, Days of our Lives, Silver Spoons, Moonlighting, The Young & the Restless & others. He earlier was an actor at Knott's Berry Farm and went on to become an Army Officer, serving in Vietnam, as well as a College Professor & professional Singer/Songwriter. I asked the humble 76-year-old fellow to tell us more about his fascinating life:

Frank Pangborn: "I attended Orangeview Junior High School & lived in the Flower Street subdivision, across from a large open field near the corner of La Palma and Dale Streets. Not long after moving to Buena Park in 1959, the field became the Buena Park Mall. A mile down the street from my home was Knott's Berry Farm. It was an Open Farm, with no fencing and we'd go over there to stroll through the Ghost Town.

Although I lived in Buena Park, my home was within the Anaheim School District boundary lines. I was in the first graduating class of Savanna High School (1963). I was lucky to be named, "Athlete of the Year" in 1963 and obtained a scholarship to San Jose State University to play football and baseball. I also played for the Anaheim American Legion team that went to Yountville for the State Championships. In my Junior Year at Savanna, we won the CIF Single A championship in baseball.

"My parents taught me to do the best that I could at whatever I did, whether it was at school, in sports or delivering newspapers. Those lessons followed me throughout my life. Good things come to those who work hard at what they do. That philosophy has worked for me throughout my career as a College Professor, Athlete, TV Actor and Singer/Songwriter (He wrote a sensational song you can hear at youtube.com, called, "Christmas USA by Frank Pangborn") and Author ("The Battles' Over: A Vietnam Soldier's Poems", "Fear In The Wind", and "Snow Cloud-Santa's Horse").

"While attending San Jose State, I worked at Knott's Berry Farm on the Stagecoach every Summer, Winter and

Spring Break. I even got to hold up the stage. Knott's is where I fell in love with horses and later owned, trained, and showed Black Arabian Horses. After college, I enlisted in the Army & went to Officer's Candidate School. I was commissioned as an Infantry Officer and spent a year as a Platoon Leader in Vietnam with the 1st Air Cavalry Division, serving in Vietnam (1969-70). I joined Chapter 785 of the Vietnam Veterans of America and soon became President of the Chapter.

Since then I joined the Freedom Committee of Orange County, whose purpose is to "Pass the torch of liberty on to future generations through a living history program". We go out to schools and speak to classes about our experiences in the service. I was Vice President of that organization.

"During the last few years, I sang with "The Forever Young Band," America's Oldest Act of Professional Entertainers from TV, the Movies and Broadway.

I loved my years growing up in Buena Park. My life has been well-lived, enjoying my 4 children and 10 grandchildren. One grandchild, Summer Faught, was the Illustrator on my children's book, "Snow Cloud: Santa's Horse." She is an excellent artist and the experience of collaborating on the book with her has created a special experience between the two of us. We plan on doing some other books together."

(Frank, who now lives in Big Bear City, also spent 8 years, first as a high school teacher & counselor at Villa Park High School, and an Administrator in charge of Regional Occupational Programs, before spending 31 years as a Professor at Irvine Valley College.)

Hugo, a self-taught artist from Southern California, has been creating art for seven years and specializes in portraiture. Working with oil paint and charcoal, his work is known for capturing the feeling and gaze of his subjects making him highly sought after. The result is a beautiful piece that not only incorporates the #JuntosMásFuertes message, but also intertwines the OCSC Crest in a mosaic border alongside one of the more iconic landmarks in North OC - the Santa Ana Water Tower.

Hugo stated, "I am very honored to be able to create with OCSC, to give back to the community and its young creatives. Community is very important, it inspires, it creates culture and unity. I hope that my art inspires, just like the community of Santa Ana has inspired me with its unity and heritage."

Since the 1980's, Santa Ana has been the art destination for Orange County, attracting artists, art lovers and art professionals to the area and the Orange County Soccer Club plans to continue their support in preserving this culture with future projects.

Orange County Soccer Club (OCSC) is Orange County's only professional soccer team and is part of the United Soccer League (USL), the fastest-growing Division II professional soccer league in the world. The USL is comprised of 35 teams across the United States. The team plays its home games at the 5,500-seat Orange County Great Park Championship Soccer Stadium, located in Irvine, CA. OCSC's strategic partner is Rangers Football Club of Glasgow in the Scottish Premier League. OCSC signed the youngest male in United States soccer history to a professional contract, Francis Jacobs, in 2019 at the age of 14. The team executed a number of player transfers from the

USL to major European clubs in 2020, including to the German Bundesliga (Wolfsburg) and to the Scottish Premier League (Rangers FC). OCSC's preceding club, Orange County Blues, was one of 12 founding members of the USL during its inaugural 2011 season. Team owner and Chief Investment Officer of LARO Properties, James Keston, purchased and re-branded the team in 2017. Keston, who actively oversees all operations

of the team, is dedicated to providing a pathway to professional soccer and a world-class soccer organization that focuses on the fans, players, and youth clubs of Orange County.

count of a lewd act on a child between the age of 14 and 15, one felony count of luring a child with criminal intent, one

felony count of meeting a minor to commit lewd conduct, two misdemeanor counts of soliciting, engaging or agreeing to engage in prostitution with a minor and one misdemeanor count of arranging to meet a minor for lewd conduct.

"No matter how many ways predators continue to try to disguise their sexual abuse of children, the Orange County District Attorney's Office and our law enforcement partners will never stop protecting these vulnerable victims. Working together we will continue to outsmart those who prey on innocent children, arrest them, and prosecute them. No child should have to suffer sexual abuse and we will hold these monsters accountable."

The Orange County Human Trafficking Task Force's top priority is the protection of minors against commercial sexual exploitation. This effort continues

to become more difficult due to the abundant number of dating and other social media sites. Some of these sites are openly used to advertise sex for money while others become unwitting participants when their sites are hijacked or misused by child predators.

The fact remains, countless number of minors continue to be sexually exploited online. One of the draws by sexual predators to online sites is the benefit of anonymity. Anyone can portray themselves to be someone they are not. Unfortunately, this trend continues to increase at an exponential rate, increasing the number of minors being exploited.

Anaheim Police Chief Jorge Cisneros stated, "The benefit of anonymity also works in law enforcement's favor. Let those looking to sexually exploit children, or any victim be warned. We are investigating these crimes and will bring you to justice, which these suspects now know, firsthand."

It is important to note that once found, these perpetrators are being charged with solicitation of a minor in addition to felony sex charges.

Deputy District Attorney Kellie Wiemann of the Human Exploitation and Trafficking (HEAT) unit is prosecuting these cases.
