The 2017 approval included a resolution which authorized automatic future rate adjustments for pass through costs. The city would again authorize automatic adjustments for pass-through costs; as needed be in addition to the water rate adjustments being proposed in this notice. Your Water Bill

The City of Westminster water rates consist of two parts: the Total Fixed Charge and the Commodity Charge. The Total Fixed Charge consists of each customer's meter size charge and a charge that is uniformly applied to all water accounts. These charges recover the fixed costs of operating the water system which do not vary with the volume of water used by a customer. Examples of these costs are meter reading and customer billing. The Commodity Charge, on the other hand, is levied to recover the variable costs based on the amount of water used by water system customers.

#### The proposed rate changes affect both the Total Fixed Charge and the Commodity Charge.

### **Proposed Rate Adjustments**

The City collects water charges to fund the City's costs of providing clean, reliable water service to its water customers. Proceeds of water charges cannot be used by the City for any other purpose, and the rates have been designed so that no customer is charged for more than his or her proportional share of the cost of providing water service.

During the past few years the cost of purchasing water from the Municipal Water District of Orange County and the Orange County Water District has increased significantly. The cost to operate the system has also increased, particularly power costs. To meet these costs and ensure the continued provision of safe and reliable water to our water customers, the City is proposing rates be adjusted as stated in the attached table. For a typical residential customer using 20 units of water in 8 weeks, this equates to a bill increase of about \$1.73 per 8 weeks in 2021. If approved, the new rates will be reflected on bills starting April 20th 2021.

The proposed water rates were calculated by the City staff and its rate consultant to allocate applicable costs among water customers according to the cost of providing service to each customer. Customer
