NOTICE IS HEREBY GIVEN that on March 23, 2022, the City Council of the City of Westminster duly passed and adopted an Ordinance entitled:

ORDINANCE NO. 2584

AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, ESTABLISHING THE REDISTRICTING BOUNDARIES OF EACH ELECTORAL DISTRICT - FIVE DISTRICTS
The City of Westminster ("City") is a general law city, which is currently governed by a directly elected mayor and four (4) council members elected from four (4) districts. City Council districts are established and governed by Section 2.04.120 of the Westminster Municipal Code.

A ballot measure has been placed on the June 7, 2022 primary ballot, which, if approved, would eliminate the directly elected mayor position, and instead elect five (5) council members from five (5) districts with the mayor position rotating among the council members. Ordinance 2584 adopted Redistricting Map 507, which establishes the district boundaries for the five (5) city council districts and sets the election years for each of the five (5) districts. Ordinance 2584 shall only be implemented should the June 7, 2022 ballot measure, eliminating the directly elected mayor and establishing five (5) council districts with a rotating mayor position, be approved.

Pursuant to California Elections Code 9235 ordinances relating to an election go into effect upon the approval of the second reading, provided that Ordinance 2584 will only be implemented if the June 7, 2022 ballot measure is approved. The City Council conducted introduction and first reading on March 9, 2022. The City Council at its Regular Meeting on March 23, 2022 conducted second reading, passed, and adopted Ordinance No. 2584, as listed above with the following roll call to wit:
