The proposed Ordinance and Amended Military Equipment Use Policy was submitted to City Council at the June 22, 2022, meeting as a "receive and file" item, and was posted on the WPD website on June 23, 2022, for public access and review for a minimum of the requisite 30 days. The item is now being submitted to the City Council for a first reading and a public hearing. A second reading and adoption of the Ordinance is scheduled for the August 10, 2022, City Council meeting.

Assembly Bill 481 (AB 481), codified as Government Code sections 7070 through 7075 requires a law enforcement agency to obtain approval from the applicable governing body, for the procurement, maintenance, and use of legislatively identified "military equipment," via the adoption of a "military equipment" use policy and resolution.

Items deemed to be "military equipment" by AB 481 are used as a component of overall best practices for law enforcement agencies, including Westminster PD throughout the country. These tools have been field tested and are used by law enforcement agencies nationwide to enhance public and officer safety. Loss of these items would jeopardize the welfare of peace officers and the citizens of Westminster whom they serve whom they serve.

The proposed ordinance seeks to approve the WPD's amended Policy § 706, which constitutes WPD's Military Equipment Use Policy. Policy § 706 outlines each item identified in Government Code section 7070, that is currently owned by the City Policy § 706 also includes the current use and cost of each item. These items, and their stated uses, have been in place prior to the implementation of AB 481.
