No construction or development is proposed in connection with the requested General Plan Amendment. The Planning Commission will consider the General Plan Land Use Amendment and formulate a recommended action for consideration by the City Council. The City Council will be the final decision review authority for the General Plan Land Use Amendment at a separate public hearing. In addition, Conditional Use Permit C-816 was approved by the Planning Commission in 1992, which authorized the construction and operation of a 17.3-acre golf center as an interim use on the above-mentioned portion of the 156-acre Westminster Memorial Park site. Recently, the lease with the prior tenant, Family Golf Centers, Inc., expired the tenant vacated the project site; and the associated buildings were demolished in April of 2022. Therefore the City is initiating its authority to revoke Conditional Use Permit C 816 since the use and structure for which the Conditional Use Permit was granted has ceased to aviet the Conditional Use Permit was granted has ceased to ENVIRONMENTAL STATUS: The General Plan Amendment and Conditional Use Permit Revocation

Amendment and Conditional Use Permit Revocation have been reviewed in accordance with the California Environmental Quality Act (CEQA) and the requirements of the City and has been deemed to be exempt from CEQA analysis based on the commonsense exemption (Guidelines Section 15061(b)(3)) and Section 15321, Class 21 (Enforcement Actions by Regulatory Agencies), respectively. Prior to the approval of a GPA Government Code §65352.3 requires local governments to consult with California Native American tribes identified by the Native American Heritage Commission (NAHC) for the purpose of preserving and protecting cultural places that may be affected by the GPA. On November 1, 2022, the Westminster Community Development Department provided written notifications invit-November 1, 2022, the Westminster Community Development Department provided written notifications inviting tribal consultation. The consultation letter included the project location, background, and description. One response was received within the 90-day period required under SB 18 from the Gabrieleno Band of Mission Indians – Kizh Nation, which indicated that they do not object to the requested GPA.
