CIL OF THE CITY OF WESTMINSTER, CALIFORNIA AMENDING CHAPTER 8.06 (SIDEWALK VENDING) TO TITLE 8 (HEALTH AND SAFETY) BY ADDING SECTION 8.06.025 (EXCEPTIONS TO REQUIRE MENT OF SIDEWALK VENDOR PERMIT), TO EXEMPT CERTAIN DESIGNATED ACTIVITIES BY MINORS FROM THE SIDEWALK VENDOR REGULAT ORY SCHEME, AND FINDING THE ORDINANCE NOT SUBJECT TO THE CALIFORNIA ENVIRONMENTAL

QUALITY ACT

Chapter 8.06, which is the Sidewalk Vendor regulatory scheme was adopted by the Westminster City Council in April 2023. Chapter 8.06, which is consistent with the mandates of both SB 946 and SB 972, regulates the time, place, and manner in which sidewalk vending is conducted, including, but not limited to imposing limits on hours of operation, requirements for maintaining sanitary conditions, ensuring compliance with the Americans with Disability Act, imposing requirements for various permits and licenses, imposing an application requirement of a sidewalk vendor, and imposing a requirement of compliance with other generally applicable laws ment of compliance with other generally applicable laws Ordinance 2602 amends Chapter 8.06 by adding Section 8.06.025, "Exceptions to Requirements of Sidewalk Vendor Permit," by providing that the following are exempt from the provisions of Chapter 8.06:

The vending of lemonade or other similar activity by a minor under the age of 16 from a location immediately in front of their residence.
The vending of prepackaged cookies, snacks, or other candies by a minor under the age of 16, for no more

than 30 days per year, for the purposes of fundraising for a nonprofit 501(c)(3) organization, including, but not limited to the Girl Scouts of America or other similar charitable nonprofits serving children or schools.
