Chapter 8.06, which is consistent with the mandates of both SB 946 and SB 972, regulates the time, place, and manner in which sidewalk vending is conducted, including, but not limited to imposing limits on hours of operation, requirements for maintaining sanitary conditions, ensuring compliance with the Americans with Disability Act, imposing requirements for various permits and licenses, imposing an application requirement of a sidewalk vendor, and imposing a requirement of compliance with other generally applicable laws.
