For fiscal year 2024/25, the City of Westminster will have an estimated total of \$1,231,685 in CDBG funds. This total amount is comprised of an estimated \$978,995 in Fiscal 2024/25 CDBG entitlement funds and \$252,730 in prior year unallocated CDBG funds carried forward. Carryover CDBG funds are due to project savings from subre-

The City of Westminster will have \$638,645 in HOME Program funds comprised of this coming year's allocation of \$457,240, and an estimated carryover balance of \$181,405.

The City has not received notification from HUD of FY 2024/25 CDBG and HOME allocations. Therefore, CDBG and HOME funding allocations and recommendations are subject to change.

COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG)
CDBG funds are designed to assist the City in its efforts to provide decent housing, a suitable living environment community services and facility needs, and expand economic opportunities for primarily low-and-moderate income persons. The City may allocate a maximum of 15 percent of the annual CDBG entitlement to public service providers. Therefore, approximately \$146,843 is available to public service providers in FY 2024/25. The remainder of funds may be allocated to capital projects or capital improvements, and to administrative costs which are limited to 20 percent.
