AN ORDINANCE OF THE CITY OF WESTMINSTER, CALIFORNIA, ADDING CHAPTER 3.10 (TRANSACTION AND USE TAX OF 2024) TO TITLE 3 (REVENUE AND FINANCE) OF THE WESTMINSTER MUNICIPAL CORE CIPAL CODE

This City Council of the City of Westminster HEREBY ORDAINS AS FOLLOWS:

Ordinance No. 2609 adds Chapter 3.10 (Transaction and Use Tax of 2024) to the Westminster Municipal Code, which shall be known as the City of Westminster Safety, Services and Stabilization Transactions and Use Tax Ordinance of 2024, which shall become effective 110 days after adoption of the ordinance. For the privides of colling tax bribbs personal preparty to taking the ilege of selling tangible personal property at retail, this ordinance will impose upon all retailers within the City of Westminster a transaction tax at the rate of 0.5% of the gross receipts of any retailer from the sale of all tangible personal property sold at retail.

In addition, this ordinance imposes an excise tax on the storage, use or other consumption in the City of tangible personal property purchased from any retailer on and after the operative date of this ordinance at the rate of 0.5% of the sales price of the property. For the purpose of this ordinance, all retail sales are

consummated at the place of business of the retailer un-less the tangible personal property sold is delivered by the retailer or his/her agent to an out-of-state destina-tion or to a common carrier for delivery to an out-of-state destination

The ordinance also provides a list of exemptions and exclusions from the transactions and the use tax amount

Consistent with the City's ongoing commitment to citgovernment, this ordinance establishes a Citizen Oversight Committee to convene twice in a yearly period to review and discuss the use of the revenue generated by the measure.

The City Council conducted introduction and first reading on December 8, 2023. The City Council at its Regular Meeting on March 27, 2024 conducted second reading, passed, and adopted Ordinance No. 2609, as listed above with the following roll call to wit:
