Examples include isolating them from friends, relatives or other support: keeping them from food or basic needs; controlling or keeping track of them, in-cluding their movements, contacts, actions, money, or access to services; and making them do something by force, threat, or intimidation, including threats based on actual or

suspected immigration status. Coercive control includes reproductive coercion meaning controlling someone's reproductive choices, such as using force, threat, or intimidation to pressure someone to be or not be pregnant, and to control or interfere with someone's contracep-tion, birth control, preg-nancy, or access to health information.

You Must Respond: You are not required to re-

spond in writing but you are required to appear in court to respond to this action. If you do not appear or respond, the court may issue a Restraining Order for up to five years against

you.
