AN ORDINANCE OF THE MAYOR AND CITY COUNCIL OF THE CITY OF WESTMINSTER, CALIFORNIA, AMENDING THE CITY'S POLICY REGARDING THE USE OF "MILITARY EQUIPMENT

On July 28, 2024, the proposed policy was published on the Westminster Police De-partment's webpage. To comply with the terms of Assembly Bill 481 (AB 481), a thirty-day review period was initiated at that time. The item is now being submitted to the City Council for its first reading and a public hearing. If approved by the City Council at the August 28, 2024 meeting, second reading and adoption of ORDIN-ANCE NO. XXXX would be scheduled for the September 11, 2024, City Council meeting.

Assembly Bill 481 (AB 481), codified as Government Code sections 7070 through 7075, requires a law enforcement agency to obtain approval from the applicable governing body, for the procurement, maintenance, and use of legislatively identified "military equipment," via the adoption of a "military equipment" use policy and resolution.

Pursuant to AB 481, items deemed to be "military equipment" include, but are not limited to, unmanned aerial or ground vehicles, armored vehicles, command and control vehicles, pepper balls, less lethal shotguns, less lethal 40mm projectile launchers certain firearms, long range acoustic devices (LRAD), and flashbangs.

Items deemed to be "military equipment" by AB 481 are used as a component of overall best practices for law enforcement agencies, including Westminster PD throughout the country. These tools have been field tested and are used by law en-forcement agencies nationwide to enhance public and officer safety. Loss of these items would jeopardize the welfare of peace officers and the citizens of Westminster whom they serve.

The proposed ordinance seeks to approve the WPD's revised Policy § 706, which constitutes WPD's Military Equipment Use Policy. Policy § 706 outlines each item identified in Government Code section 7070, that is currently owned by the City Policy § 706 also includes the current use and cost of each item. Nearly all of these items, and their stated uses, have been in place prior to the implementation of AB 481.
