The proposed ordinance seeks to amend the Rules of Decorum for City Council Members by adding section 2.04.065 to the Westminster Municipal Code, in order to establish standards of conduct for Westminster councilmembers by setting forth those acts or actions that are incompatible with the best interests of the City and with the efficient conduct of the City's business during City Council meetings. The provisions of this new chapter and such rules and regulations are established in the best interest of the City and for the protection of the public health, safety and welfare.

California Government Code SS 38513 provides that "the council may establish rules for the conduct of its proceedings. It may punish a member or other person for disorderly behavior at a meeting. Section 2.04.060 of the WMC further provides that "... any person who per-sistently interrupts the proceedings of the council or re-fuses to be seated to keep quite when ordered to do so by the proceeding officer only the de mindemen by the presiding officer, shall be guilty of a misdemean-
