The proposed ordinance approves a Zoning Map Amendment (Case No. 2024-0252) submitted by the ap-plicant, Westminster Reliability Project, LLC. This zon-ing map amendment would remove the Planned Devel opment (PD) Overlay from the parcel located at 7002 Garden Grove Boulevard (APN 203-431-15) to better align the zoning designation with the parcel's intended use. The amendment is proposed in conjunction with a Conditional Use Permit (CUP) and Development Review (DR) for the construction of a utility facility operating as a battery energy storage system. The facility includes 172 battery storage enclosures, 43 medium voltage transformers, and other associated electrical equipment, which will connect to the adjacent Southern California Edison substation. The CUP and DR applications were approved by the Westminster Planning Commission on November 6, 2024. Adoption of the proposed ordinance is categorically exempt from the California Engineering Condition of CECA (CECA) under CECA posed ordinance is categorically exempt from the California Environmental Quality Act (CEQA) under CEQA Guidelines Section 15332, Class 32, In-Fill Development Projects.

The City Council will conduct the second reading and adopt the Ordinance at its Regular Meeting on January 8, 2025, scheduled to commence at 6:00 p.m.
