The ordinance amended the Rules of Decorum for City Council Members by adding section 2.04.065 to the Westminster Municipal Code, in order to establish standards of conduct for Westminster councilmembers by setting forth those acts or actions that are incompat-ible with the best interests of the City and with the efficient conduct of the City's business during City Council rules and regulations are established in the best in-terest of the City and for the protection of the public health, safety and welfare.

California Government Code SS 38513 provides that the council may establish rules for the conduct of its proceedings. It may punish a member or other person for disorderly behavior at a meeting.
