This zoning map amendment would remove the Planned Development (PD) Overlay from the parcel located at 7002 Garden Grove Boulevard (APN 203-431-15) to better align the zoning designation with the parcel's intended use. The amendment is proposed in conjunction with a Conditional Use Permit (CUP) and Development Review (DR) for the construction of a utility facility operating as a battery energy storage system. The facility includes 172 battery storage enclosures, 43 medium voltage transformers, and other associated electrical equipment, which will connect to the adjacent Southern California Edison substation.
