The ordinance establishes regulations for unlawful camping in public parks, public rights-of-way, and public facilities including the storage of personal property in these public locations. Additionally, the ordinance prohibits obstructing access to roads or buildings, preserves clear passages for ADA (Americans with Disabilities Act) access (including to private properties), includes a list of specified clearance distances from specified public and private locations, and defines the exceptions that do not constitute a violation. The ordinance also contains an enforcement process by which violations are noticed, and penalties are assessed.
