The purpose of the proposed ordinance is to amend Chapter 17.500 by removing burdensome procedural requirements for both applicants and staff with regard to the provision that mandates a strict six-month expira-tion if the proposed project is not deemed complete, or if, after being deemed complete, the application is delayed due to the applicant or property owner's condetayed due to the applicant or property owner's conduct. Staff determined that, particularly with large projects, the six-month period is an inadequate amount of time to allow an applicant to gather information requested by staff and to respond to staff's comments. Removal of this strict six-month expiration period and allowing for a three (3) month extension would effectively comove an impediment to development within the City. remove an impediment to development within the City

Ordinance No. 2621 will add language to Section 17.500.025 ("Initial Application Review") that would expire applications based upon the unresponsive nature of applicants, and not on a set strict schedule. This additional language would thus allow the applicant a threemonth extension, before a project is deemed expired. This additional language of allowing for the three-month extension window will be sufficient to allow an applicant to respond to staff's incomplete letter and therefore provide any additional required information.

Ordinance No. 2621 also clarifies other parts of the

code concerning when a project is considered with-drawn. The current code text calls for a project to be considered withdrawn when a project is "delayed as a result of the applicant(s) and/or property owner(s) con-duct." In order to further remove constraints on the development of housing, this Ordinance contains lan-guage that would establish a defined three-month timeline for action on a project.

Ordinance No. 2621 also corrects an inconsistency in Section 17.500.030 (Environmental Assessment) by adding in a key step in the CEQA process.

PUBLIC NOTICE ADOPTED ORDINANCE NOTICE IS HEREBY GIVEN that on June 11, 2025, the City Council of the City of Westminster adopted an Ordinance entitled:

ORDINANCE NO. 2620

AN ORDINANCE OF THE MAYOR AND CITY COUN-CIL OF THE CITY OF WESTMINSTER, CALIFORNIA AMENDING ORDINANCE NO. 2139 AND AMENDING SECTION 13.08.130 OF THE WESTMINSTER MUNI-CIPAL CODE TO UPDATE THE CROSS-CONNEC-TION CONTROL PROGRAM OF THE CITY'S WATER DIVISION

The ordinance is: (1) to protect the public water supply against actual or potential cross-connection by isolating within the premise contamination that may occur be-cause of some undiscovered or unauthorized cross-connection on the premises; (2) to eliminate existing connections between drinking water systems and other sources of water that are not approved as safe and potable for human consumption; (3) to eliminate cross-connections between water systems and sources of contamination; and (4) to prevent the making of cross-con-nections in the future. These regulations are being ad-opted pursuant to the State Water Resource Control Board (SWRCB), which has completed the develop-ment and adoption of an updated and revised Cross-Connection Control Policy Handbook (CCCPH).

This ordinance will implement a cross-connection control program to protect the City of Westminster's water system, that includes the elimination and/or protection of all cross-connections by approved methods or approved equipment called backflow prevention assemblies. This is to ensure the protection of the public health by preventing any potential contaminated water from entering the drinking water distribution system.

Ordinance No. 2620 will make it unlawful for any person, firm, or corporation at any time to make or maintain or cause to be made or maintained, temporarily or permanently, for any period of time whatsoever, any cross-connection between plumbing pipes or water fix-tures being served with water by the City water depart-ment and any other source of water supply or to maintain any sanitary fixture or other appurtenances or fix-tures which by reason of their construction may cause or allow backflow of water or other substances into the water supply stem of the City and/or the services of water pipes or fixtures of any consumer of the City.

The City Council conducted introduction and first reading on May 14, 2025. The City Council at its Regular Meeting on June 11, 2025, conducted second reading passed and adopt Ordinance No. 2620, as listed above with the following roll call to wit:
