AN ORDINANCE OF THE MAYOR AND CITY COUN-CIL OF THE CITY OF WESTMINSTER, CALIFORNIA APPROVING A ZONING TEXT AMENDMENT (CASE NO. 2025-0176) AMENDING TITLE 16 OF THE WEST-MINSTER MUNICIPAL CODE, CHAPTER 16.12 DIVISION OF LAND BY PARCEL MAP FOR AN URBAN LOT SPLIT AND TITLE 17, SECTION 17.400.122 OF THE WESTMINSTER MUNICIPAL CODE SB 9 TWO UNIT HOUSING DEVELOPMENT IN THE R1 DIS-TRICT The purpose of the proposed ordinance is to implement

Senate Bill 9 (SB 9) which became effective on January 1, 2022, which requires that local agencies must by law ministerially approve, without discretion or hearing, a housing development of no more than two residential units on a single-family residential zone lot when the proposed development meets certain requirements. SB 9 also requires a local agency to ministerially approve a parcel map for an "urban lot split" in an R1 zoned lot, to divide a lot into two separate lots, when the map meets certain requirements.

Although the City Council adopted an urgency ordinance on January 12, 2022, to implement SB 9 with objective standards and procedures consistent with State law, the State Senate passed SB 450, a legislative update to SB 9, which took effect on January 1, 2025. SB 450 adopted several key changes to the SB 9 provisions as follows: 1) A local agency may no longer impose objective standards that do not uniformly apply to development in the underlying zone. This means that the requirements may not be more restrictive than requirements applied to single-family development in the R1 zone and that they must be free of personal or sub-R1 zone and that they must be free of personal or sub-jective judgment; and 2) A local agency shall consider and approve or deny an application within 60 days from the day the agency receives a complete application.

Compliance with State law, requires that the City adopt a revised ordinance to ensure that the Westminster Mu-nicipal Code (WMC) contains objective standards that meet all current State requirements.

The majority of the changes proposed in the new ordinance will satisfy the state requirement that only objectance will satisfy the state requirement that only objective standards applied to all developments in the underlying zone may be required for SB 9 units. In addition, since the SB 9 ordinance was first introduced in 2021, the State Department of Housing and Community Development (HCD) has provided clarification that cities must allow new or existing JADUs and ADUs in conjunction with SB 9 units. Therefore, the proposed ordinance also reflects this requirement ance also reflects this requirement. The City Council will conduct a second reading and ad-

AN ORDINANCE OF THE MAYOR AND CITY COUN-CIL OF THE CITY OF WESTMINSTER, CALIFORNIA APPROVING A ZONING TEXT AMENDMENT (CASE NO. 2025-0183) AMENDING TITLE 17 OF THE WEST-MINSTER MUNICIPAL CODE, CHAPTER 17.400.135 RESIDENTIAL USES – ACCESSORY DWELLING The purpose of the proposed ordinance is to update the Westminster Municipal Code (WMC) which is out of compliance with Assembly Bill (AB) 2299 and Senate Bill (SB) 1069, both of which amended the Government

Code to make it easier for property owners to develop second units, also referred to as Accessory Dwelling Units (ADUs) on residential properties. These laws initially allowed ADUs on nearly all residential properties tially allowed ADUs on nearly all residential properties and limited the ability of local government to impose development standards such as parking, setbacks, and unit size. Although the Westminster City Council had already adopted ordinances to implement both AB 2299 and SB 1069, the state has since passed additional bills (i.e., SB 1211, AB 2221 and SB 897) which have further reduced the ability of local governments to regulate development standards for ADUs and which have modified the number of ADUs which a property is entitled to fied the number of ADUs which a property is entitled to.

For example, SB 1211, passed in 2024, builds upon ex-For example, SB 1211, passed in 2024, builds upon existing ADU legislation to significantly increase the number of detached ADU's you can build on properties with multifamily housing. SB 1211 now allows a developer to build up to 8 detached ADUs, which is a significant jump from the previous limit. However, an ADU density cap provides that the number of ADUs developed cannot exceed the number of existing units in the main multifamily building. AB 2221 and SB 897, passed in 2022, combined to increase the minimum height a city must allow bined to increase the minimum height a city must allow for a detached ADU if the unit is located within a half mile of a major transit stop or high quality transit corridor to 18 feet (20 feet if necessary to match the roof pitch of an existing residence) and for an attached ADU to 25 feet or as high as a primary dwelling unit may be per the underlying zoning.

This ordinance will update the WMC so that it complies with state law. Furthermore, the 6th Cycle Housing Element, which was approved by the City Council and certified by the California Department of Housing and Community Development, contains Program 5 which requires to City to update its ADU code section to be compliant with state law.
