The purpose of the proposed ordinance is to update the city's municipal code by adopting the 2025 editions of the California Building Standards with local amend-

California Health & Safety Code Section 18938 makes certain provisions published in the California Building Standards Code pursuant to Health and Safety ("H&S") Code Section 17922 applicable to all occupancies throughout the state. H&S Code Section 17958 permits cities to amend the requirements of the California Building Standards Code in accordance with H&S Code Section 17958.5 and 17958.7. In addition, cities are permit ted to make modifications to the provisions of the Cali fornia Building Standards Code that are being adopted pursuant to H&S Code Sections 17958.5 and 17958.7 that are reasonably necessary because of local climatic geological, or topographical conditions.

H&S Code Section 17958.7 requires that the City Council, before making any modifications or changes to the Codes, make an express finding that such changes or modifications are reasonably necessary because of the local climatic, geologic, or topographic conditions. The City Council of Westminster has determined that it would adopt an ordinance adopting by reference certain provisions of the California Building Standards Code and making modifications to certain of those provisions pursuant to H&S Code Section 17958.5 ("Building Regulations Adoption Ordinance").

Ordinance 2629 adopts in full the 2025 editions of the California Building Code, the California Residential Code, the California Electrical Code, the California Mechanical Code, the California Plumbing Code, the California Energy Code, the California Existing Building Code, the California Green Building Standards Code the California Wildland-Urban Interface Code, the California Fire Code, the California Historical Building Code the California Referenced Standards Code, and the 2024 International Property Maintenance Code. The aforementioned codes together with certain amendments, deletions, exceptions, and qualifications, generally deal with all aspects of building construction, specification of building materials, plumbing design, water supply and drainage systems, approved construction and plumbing techniques, electrical specifications, engineering formulas to be utilized during building design fire safety systems for residential buildings, retrofitting techniques, energy conservation techniques, and special requirements dealing with fire and seismic safety

The City Council will conduct a second reading and adopt the Ordinance at its Regular Meeting on November 12, 2025, scheduled to commence at 6:00 p.m., or as soon thereafter as the matter may be heard.
