This means that development in the underlying zone. In addition since the SB 9 ordinance was first introduced in 2021 the State Department of Housing and Community Development (HCD) has provided clarification that cities must allow new or existing JADUs and ADUs in conjunction with SB 9 units. Therefore, this ordinance also reflects this requirement.

#### **ORDINANCE NO. 2628**

AN ORDINANCE OF THE MAYOR AND CITY COUN-ORDINANCE OF THE MATCH AND CITY COUNT CIL OF THE CITY OF WESTMINSTER, CALIFORNIA, APPROVING A ZONING TEXT AMENDMENT (CASE NO. 2025-0183) AMENDING TITLE 17 OF THE WEST-MINSTER MUNICIPAL CODE, CHAPTER 17.400.135 RESIDENTIAL USES - ACCESSORY DWELLING UNITS

The purpose of this ordinance is to update the Westminster Municipal Code (WMC) which is out of compliance with Assembly Bill (AB) 2299 and Senate Bill (SB) 1069, both of which amended the Government Code to make it easier for property owners to develop second units, also referred to as Accessory Dwelling Units (ADUs) on residential properties. These laws initially allowed ADUs on nearly all residential properties and limited the ability of local government to impose development standards such as parking, setbacks, and unit size. Although the of local government to impose development standards such as parking, setbacks, and unit size. Although the Westminster City Council had already adopted ordinances to implement both AB 2299 and SB 1069, the state has since passed additional bills (i.e., SB 1211, AB 2221 and SB 897) which have further reduced the ability of local governments to regulate development standards for ADUs and which have modified the number of ADUs which a property is entitled to.

For example, SB 1211, passed in 2024, builds upon existing ADU legislation to significantly increase the number of detached ADU's you can build on properties with multifamily housing. SB 1211 now allows a developer to build up to 8 detached ADUs, which is a significant jump from the previous limit. However, an ADU density cap provides that the number of ADUs developed cannot exceed the number of existing units in the main multifamily building. AB 2221 and SB 897, passed in 2022, combined to increase the minimum height a city must allow for a detached ADU if the unit is located within a half mile of a major transit stop or high quality transit corridor to 18 feet (20 feet if necessary to match the roof pitch of an existing residence) and for an attached ADU to 25 feet or as high as a primary dwelling unit may be per the underlying zoning.

This ordinance updates the WMC so that it complies with state law. The purpose of this ordinance is to update the city's municipal code by adopting the 2025 editions of the California Building Standards with local amendments.

California Health & Safety Code Section 18938 makes California Health & Safety Code Section 18938 makes certain provisions published in the California Building Standards Code pursuant to Health and Safety ("H&S") Code Section 17922 applicable to all occupancies throughout the state. H&S Code Section 17958 permits cities to amend the requirements of the California Building Standards Code in accordance with H&S Code Section 17958.5 and 17958.7. In addition, cities are permitted to make modifications to the provisions of the California Building Standards Code that are being adopted pursuant to H&S Code Sections 17958.5 and 17958.7 that are reasonably necessary because of local climatic. that are reasonably necessary because of local climatic geological, or topographical conditions.

H&S Code Section 17958.7 requires that the City Council, before making any modifications or changes to the Codes, make an express finding that such changes or modifications are reasonably necessary because of the local climatic, geologic, or topographic conditions. The City Council of Westminster has determined that it would adopt an ordinance adopting by reference certain provisions of the California Building Standards Code and making modifications to certain of those provisions pursuant to H&S Code Section 17958.5 ("Building Regulations Adoption Ordinance") ulations Adoption Ordinance").

Ordinance 2629 adopts in full the 2025 editions of the California Building Code, the California Residential Code, the California Electrical Code, the California Mechanical Code, the California Plumbing Code, the California Energy Code, the California Existing Building Code, the California Green Building Standards Code, the California Wildland-Urban Interface Code, the California Fire Code, the California Historical Building Code, the California Referenced Standards Code, and the 2024 International Property Maintenance Code. The aforementioned codes together with certain amendments, deletions, exceptions, and qualifications, generally deal with all aspects of building construction, specification of building materials, plumbing design, water supply and drainage systems, approved construction and plumbing techniques, electrical specifications, engineering formulas to be utilized during building design, fire safety systems for residential buildings, retrofitting techniques, energy conservation techniques, and special sourcement dealing with five and actions of the techniques, energy conservation techniques, and special requirements dealing with fire and seismic safety.
